In order to effectively draw out the stain, renew the cleaning cloth as often as necessary to maintain an absorbent surface.

Spot clean with upholstery shampoo, foam from a mild detergent, or mild dry cleaning solvent. Hot water extraction or steamcleaning is not a recommended cleaning method. Clean spots or stains from the outside to the middle of the affected area to prevent circling.

For light cleaning, use soap and water.

For difficult stains, use Fantastik® or Formula 409®.

For disinfecting, use a 5:1 water/bleach diluted solution.
